Subject: Withdrawal of Sponz from APOGEE 2025

The Department of Sponsorship & Marketing (Sponz) is **withdrawing all efforts towards securing sponsorship and fulfilling deliverables for APOGEE 2025** unless the following conditions are met **before the fest**:

1. **Official Reinstatement of Sponz as a Major Department in Oasis 2025** by the SU, EC, and CRC.
2. **Written Guarantee that no unfair actions will be taken against the department in APOGEE 2025.**

Despite securing a **record-breaking ₹40 lakh in cash sponsorships for Oasis 2024**, our department was **demoted to a minor department in Oasis 2025** due to **personal biases and political maneuvering** by certain members of the Union Council, including **General Secretary Aryan Khorana**, who additionally also lobbied the Oasis Review Committee (ORC) to vote against Sponz, ensuring we did not secure the required votes. This decision, made without merit, has left our team demotivated after all the hard work we put in to make Oasis 2024 a success.

For APOGEE 2025, we have already secured **₹13.2 lakh of the ₹20 lakh target** within two months and have **strong leads in the pipeline** that will help us surpass our goal and reach a total of more than **₹22 lakh**. However, we are now hearing that the same individuals who targeted us during Oasis are planning to do the same for APOGEE, **regardless of our performance.**

We refuse to work in an environment where our efforts are **deliberately undermined and punished**. Our withdrawal is not due to incompetence—it is a **stand against unjust**
